

Why did Israel and the Emirates sign a trade agreement?

While Israel and the Emirates had long-maintained de facto recognition in areas of business including the diamond trade, and high tech industries including artificial intelligence and defense, the accord opened the door to a much wider range of economic cooperation, including formal investments.

How have the Abraham Accords changed the Middle East?

They have led to new forms of cooperation in the Middle East and beyond. Three years on, the Abraham Accords are delivering on their promise of expanded trade and commerce, deeper people-to-people ties and a more integrated region.

Did Israel sign a joint security agreement with Morocco?

In November 2021, the Israeli minister of defense, Benny Gantz, signed a joint security understanding agreement with Moroccan defense minister Abdellatif Loudiyi, the first time that Israel openly signed such an agreement openly with an Arab state.
