Will a 500 MW photovoltaic module be built in Bourgoin-Jallieu?

Carbon has proposed a EUR40 million investment to create a 500 MW photovoltaic module production unit at Photowatt's Bourgoin-Jallieu site, set for completion by the end of 2025.

Did carbon buy Photowatt?

Carbon has acquired Photowattand says it will invest EUR40 million (\$44.6 million) to support its activities. From pv magazine France French solar module manufacturer Carbon has completed the acquisition of PV maker Photowatt from EDF Renouvelables, a subsidiary of French energy giant EDF.

Why did EDF acquire Photowatt?

Photowatt will also serve as a pilot facility for testing and refining module production. EDF Renewables, which acquired Photowatt in 2012, had been seeking an industrial partner to manage the 170-employee factory, which has faced financial challenges due to Chinese competition.

Will EDF renewables buy Photowatt?

"EDF Renewables considers that the acquisition project for Photowatt proposed by Carbonwould provide new impetus to sustain the company's activity and secure jobs on the site," said Bruno Fyot,deputy CEO of EDF Renewables. Carbon still needs to secure EUR1.7 billion to build its 5 GW factory in Fos-sur-Mer,France.

Who owns Elgin solar?

For example,in July 2023, Elgin sold 100MW of solar PV projects to Pennon Power, a wholly-owned subsidiary of the British water utility Pennon Group. Pennon Power acquired the solar portfolio consisting of three projects ranging from 15MW to 50MW.
