



# After tomorrow lockers can be sold

How do I know if a storage locker is a private seller?

If a storage locker is a Non-Lien unit, you will see the flag pictured below on the listing. Private Sellers are individuals who are not affiliated with a storage facility. They place items of their choosing into a storage unit they are renting and sell the unit as one lot.

When can I auction off a storage unit?

The legal period for auctioning off a storage unit varies from one state to another. Make sure to check your storage unit auction laws in the state where your facility is operating. There is also a specified date for when storage owners can place an advertisement and hold the auction.

Can You Redeem a storage unit before it is sold?

Most states allow you to redeem your property before it is sold. This means that there is a grace period where you can repay all outstanding debts before your storage unit contents are sold. The storage company must notify the storage unit tenant of the intention to sell the goods inside.

What happens if I buy a unit from a private seller?

If you purchase a unit from a Private Seller, you will not go to the storage facility office to pay. You will need to meet with the Private Seller personally. The storage facility will not be involved in the sale in any way. You might also run across a unit for Charity Storage.

Can You Win forfeited storage items at auction?

There are laws on the books to protect both renters and storage unit providers. Additionally, people seeking to win forfeited storage items at auction will want to know their legal parameters. While laws vary from one state to another, there are some commonalities.

Should you buy a storage unit downtown or outskirts?

A storage unit downtown will typically be pricier than one on city outskirts or rural areas because demand is higher there. So choose wisely. The extras add up too. If your belongings require special conditions such as climate-controlled units or extra security measures, expect those costs to increase accordingly.
