Did General Electric buy Alstom Power?

General Electric (NYSE:GE) on Monday announced the completion of its \$10.6 billion acquisition of Alstom Power, which joins GE Power & Water to form GE Power.

#### Will GE Power & Water merge with Alstom Power?

The firm has announced that, following the completion of the acquisition, GE Power &Water will combine with Alstom Power to form GE Power. Integration of Alstom power unit's technology and geography and GE's power generation technologies, services and specialisation is expected to boost the global energy utility sector.

#### Who is Alstom & GE Power?

Alstom has also successfully delivered India's first 800-kV High Voltage Direct Current (HVDC) power transformer for the Champa-Kurukshetra project. #### Does GE own Alstom?

PARIS,FRANCE - November 2,2015 - GE [NYSE:GE]announced today that it has completed the acquisition of Alstom's power and grid businesses. The completion of the transaction follows the regulatory approval of the deal in over 20 countries and regions including the EU,U.S.,China,India,Japan and Brazil.

### What happened to GE & Alstom?

In 2014,GE and Alstom reached a deal for the sale of Alstom's power and grid businesses for about \$13.6 billion. Ultimately, approval from the EU required Alstom sell its gas turbine business to another European company, therefore changes in the deal structure saw the transaction close for about \$10.6 billion.

This case involves a breach of contract dispute between the plaintiffs (collectively "Dominion Resources") and the defendant, Alstom Power, Inc. ("Alstom"). On September 1, 2017, Dominion Resources filed a Motion to Exclude the Testimony of Alstom's Proposed Expert, Tommy Michaels.
