Who is Angola's largest oil & gas producer?

Azule Energy is now Angola's largest independent equity producer of oil and gas, holding 2 billion barrels equivalent of net resources and growing to about 250,000 barrels equivalent a day (boe/d) of equity oil and gas production over the next 5 years.

Does BP have oil blocks in Angola?

BP is the operator of blocks 18 and 31 and has stakes in blocks 15, 17, 20, and 29, in addition to holding stakes in NCG and Angola LNG. BP owns blocks 18 and 31 in Angola. British oil companies BP and Italian Eni created Azule Energy, a new independent international energy company in Angola, an investment of more than US\$10 billion, to produce oil and gas.

What are the major energy projects in Angola?

These include the Agogo Full Field and PAJ oil projects in Blocks 15/06 and 31 respectively, and the New Gas Consortium (NGC), the first non-associated gas project in the country, which will support the energy needs of Angola's growing economy and strengthen its role as a global LNG exporter.
