Should Angola increase access to electric power?

Increasing the access to electric power is a high priority for the Government of Angola, which has set targets of 9.9 gigawatts (GW) of installed generation capacity and a 60% electrification rate by 2025.

What is Angola's energy mix?

Angola's current installed capacity is estimated at 5.7 GW but only 70 percent is in use. The country's current energy mix consists of 61.8 percent hydropower,37.6 percent other fossil fuels and 0.6 percent hybrid (solar/fossil fuel).
