

# **Are energy storage containers considered hazardous chemicals**

Where should hazardous substances be stored?

Hazardous substances should be stored in an area with a clear exit, and it is also advised that the storage area should be close to washing facilities. Substances may also need to be stored in appropriate COSHH cabinets, and should always be stored separately from any others. Furthermore, storage areas should be separate from process areas.

Normally the storage area will be determined by the more hazardous property of the chemical and having assessed the consequences in the event of an accident in the storage area. If a chemical is both flammable and corrosive it would be appropriate for the chemical to be stored with other flammables.

This fourth edition of Chemical warehousing is aimed at anyone who has responsibility for the storage of dangerous substances, regardless of the size of storage facility. It sets out control measures aimed at eliminating or reducing risks to people - at work or otherwise - from the storage of packaged dangerous goods.

What are hazardous substances?

Hazardous substances refer to individual chemical substances as well as preparations that include a mixture of one or more such as paint, cleaning materials and pesticides. However, these regulations do not cover lead, asbestos or radioactive substances, with these being subject to their own specific regulations.

How to control risks from the storage of dangerous packaged substances?

91 It is recommended that the means adopted to control risks from the storage of dangerous packaged substances be written into the company safety policy. A periodic review of these matters should be carried out, particularly if storage conditions change.

One of the measures is to store hazardous substances and chemicals in a secure, locked chemical storage container or COSHH cabinet that is only accessible to authorised personnel. The storage area should also be marked ...

To store hazardous chemicals, you will need a specially converted unit. Installing a bunded floor - typically a large metal tray with a mesh grid - ensures chemical spillages are safely contained ...
