Are Bonaire and Sint-Eustatius honoured?

Late last week,the good news was received that the project proposals of Bonaire,Sint-Eustatius and Saba were honoured. They are the only islands in the Caribbean whose proposals made it through the selection.

What is the population of Bonaire Sint Eustatius and Saba?

The total population of Bonaire, Sint Eustatius and Saba was 26,500 in January 2022. The population increased by 211 (+0.8 percent) compared to the previous year. The population is 26,500 with 48.4 percentbeing female and 51.6 percentbeing male.

How much does energy cost in Bonaire?

This profile provides a snapshot of the energy landscape of Bonaire, a special municipality of the Kingdom of the Netherlands located of the coast of Venezuela. Bonaire's utility rates are approximately \$0.35 per kilowatt-hour(kWh), above the Caribbean regional average of \$0.33/kWh.

Is Bonaire a sustainable island?

Bonaire,a Caribbean island grappling with distinctive energy challenges stemming from its geography,population growth,and socio-economic disparities,has exhibited notable progress in transitioning from fossil fuels to renewable energy sources. Despite heavily relying on non-renewable energy,Bonaire is committed to enhancing sustainability.

How does Bonaire's electricity system work?

Presently,Bonaire's electricity grid operates autonomously,with 30% of its energy derived from renewable sources. The forthcoming decommissioning of the Morotin offshore wind farm by 2025 has catalysed collaborative efforts with stakeholders such as WEB,CGB, and BBT to devise an electrical system roadmap.

Does Bonaire have a regulated electricity sector?

In recent years, the Ministry of Eco-nomic Affairs in the Netherlands has been active in reforming the regulation of the electricity sector in Bonaire, both in terms of utility regulation and expanding generator access.13
