Did DVV buy ib vogt?

Media reports in July 2020 suggested that ib vogt had been put up for sale, with Reuters reporting that DVV hired investment bank Marathon Capital to help with the sale process. The developer went on to close a US\$160 million commitment two months later from an institutional investor to help it pursue its solar pipeline.

Will ib vogt & nextpower V ESG buy a solar project?

ib vogt and NextPower V ESG have agreed on the sale of a 110 MWp solar project in Segovia, Spain. Construction started in March 2024, with operations set for Q1 2025. The project will generate 215.6 GWh annually, powering 55,000 homes and reducing CO2 emissions by 47,450 tons per year.
