Are the Falkland Islands self governing?

The Falkland Islands are a self-governing British Overseas Territory. [73]Under the 2009 Constitution, the islands have full internal self-government; the UK is responsible for foreign affairs, retaining the power " to protect UK interests and to ensure the overall good governance of the territory ". [74]

When did Falklands get the name 'Falklands'?

The name "Falklands" was not applied to the islands until 1765,when British captain John Byron of the Royal Navy claimed them for King George III as "Falkland's Islands". [11] The term "Falklands" is a standard abbreviation used to refer to the islands.

What is the capital of the Falklands?

The capital and largest settlement is Stanleyon East Falkland. The islands are believed to have been uninhabited prior to European discovery in the 17th century. Controversy exists over the Falklands' discovery and subsequent colonisation by Europeans. At various times, the islands have had French, British, Spanish, and Argentine settlements.
