What is the Heard Island & McDonald Islands Marine Reserve management plan?

The Heard Island and McDonald Islands Marine Reserve Management Plan 2014-2024is due for its 10-year statutory review. This review is being undertaken by the Australian Antarctic Division, a Division of the Department of Climate Change, Energy, the Environment and Water. We are inviting members of the public to provide comments on a:

Why should the Heard Island & McDonald Islands Marine Reserve be expanded?

The proposed expansion of the Heard Island and McDonald Islands Marine Reserve would protect unique marine and terrestrial areas of high conservation value. The islands and surrounding marine environment provide important habitat for many species and encompass a range of geomorphic features.

When is public consultation on the Heard Island & McDonald Islands Marine Reserve open?

Public consultation on the proposal to expand the Heard Island and McDonald Islands Marine Reserve and proposal to prepare a draft management plan for the reserve was open from 5 July 2024to 5 September 2024. The public comment period has now closed.

Why are Heard Island and McDonald Islands isolated?

However, the site's isolation assists in reducing anthropogenic impacts upon the site's values. Heard Island and McDonald Islands are located in the Southern Ocean, approximately 1,700 km from the Antarctic continent and 4,100 km south-west of Perth.

Is there a threat to Heard Island and the McDonald Islands?

Ongoing and accelerating climate change poses an increasing risk of fundamental alterations in biodiversity. Geological processes (primarily volcanism and glacial retreat) continue undisturbed. The overall assessment is that there is a low threatto the World Heritage values of Heard Island and the McDonald Islands if visitation remains low.

Where are Heard Island and McDonald Islands located?

Heard Island and McDonald Islands (HIMI) are a remote subantarctic island group located about 4,000 km south-west of Western Australia and approximately 1,700 km from the Antarctic continent. The HIMI exclusive economic zone (EEZ) abuts the French EEZ around the Kerguelen Islands.
