How long does it take to register a solar PV system?

Many grid operators provide confirmation of registration within a business day however some take up to 30 working daysto provide this confirmation. Your solar PV installer has the responsibility of filing this paper and should send this to you once received as you will need it to apply for the Smart Export Guarantee.

How do I register for a generator account?

The agent appointment form must be presented on company headed paper and signed by the operator of the generating station. The agent may then register for a generator account on the Renewables and CHP Register.

How do licensed electricity suppliers use the Register?
