Saint-Pierre and Miquelon benefits from a territorial envelope of EUR27 million for the period 2021-2027 and sustainable tourism has been selected as a priority sector in the Multiannual Indicative Programme.

How does the EU support Saint-Pierre-et-Miquelon?

On average, the EU has supported Saint-Pierre-et-Miquelon with a budget of EUR4 to EUR5 million per year with an approximate 40% contribution of the Collectivity's investments.
