What is a power purchase agreement? A solar power purchase agreement is a financing arrangementhat allows businesses, government agencies and educational institutions to purchase solar electricity with no upfront capital cost. You rent your roof and buy the discounted solar electricity rather than investing in a solar PV system of your own.

What happens when a solar PV contract ends?

When the contracts come to an end the customer can choose to remove the system, extend the PPA or purchase the energy system. On-site solar PV generation can take the form of either a large-scale rooftop installation on a commercial or industrial (C&I) site, or a ground-mount installation on adjacent land.

What is a power purchase agreement (PPA) in the UK?

Power Purchase Agreements in the UK are usually solar power purchase agreements as Solar PV systems are the most accessible source of renewable power. Finally, PPAs can provide businesses with a competitive advantage by differentiating them from their competitors and enhancing their reputation as environmentally responsible companies.

What is a generator sale and purchase agreement?
