## Solar power generation tax refund policy

When will solar panels pay back to the grid?

New rules introduced this week will give homes and businesses that install solar panels payments for exporting electricity back to the grid from 1 January 2020.

Will new solar homes get a payment from suppliers?

New solar homes and businesses creating and exporting electricity to the grid will be guaranteed a payment from suppliers under new laws to be introduced by the government this week (Monday 10 June).

What information is included in a solar panel tax report?

When will a new solar scheme come in?

A new plan to pay households with solar panels for the excess electricity they produce has been announced by the Government - but it won't come in before April, when the current scheme ends.

How will the new solar rules affect you?

The new rules announced this week will only apply to new installations of solar panels and other forms of renewable generation - if you already have them, this change won't impact you.

Will SEG impose tariffs on energy suppliers?

SEG will place a legal obligation on energy suppliers with over 150,000 customers -covering more than 90% of the retail market - to introduce export tariffs by 1 January 2020. Some energy suppliers, including Octopus and Bulb, are already offering new smart tariffs, with some exceeding those offered under the previous subsidy scheme.
