St. Vincent and the Grenadines recorded two homicides Friday night with the deaths of two men in unrelated incidents. The deaths of Maurice Primus, of Fair Hall, and Zack McIntosh, of Calliaqua, take the homicide count this year to 46 -- four higher than the record of 42 that was set last year.

Veron Primus was born in St. Vincent, and is awaiting trial for the 2015 murder of real estate agent Sharleen Greaves and was serving time for his first prison escape in early October 2019. After the first escape, he turned himself in to authorities within 12 hours.
