Are solar panels tax deductible in the UK?

According to the UK government's list of Energy Saving Measures (ESMs),most solar photovoltaic (PV) panels installed on residential properties in Scotland,England and Wales (plus Northern Ireland,as of 1 May 2023) are exempt from VAT,meaning there's no VAT included in the purchase and installation costs.

Is there a zero-rate VAT on solar panels?

A zero-rate of VAT on the installation of energy-saving materials (ESMs),including solar panels,in residential accommodation,was introduced on 1 April 2022. At the time,it only applied to England,Scotland,and Wales. Following a new agreement between the UK and the EU,the zero-rating was also implemented in Northern Ireland on 1 May 2023.

Is there VAT on solar panels?

For example, in Germany, there has been no VAT on solar panels or solar batteries - including both materials and installation - since January 2023. Belgium reduced VAT on solar panel systems to 6%, between April 2022 and December 2023, but it has now gone back up to 21%.

What is the VAT rate for solar panels & heat pumps?

(here). Prior to the announcement,the country's VAT rate for solar panels,heat pumps and insulation was 5%(here). However,on Dec. 7,2021,all 27 EU Member States agreed upon an updated VAT framework that would allow them to introduce 0% VAT rates on items such as solar panels and heat pumps (here and per Reuters report here).

Do I have to pay tax on solar panels?

Normally, you won't get charged VAT or income tax on this payment if you produce electricity primarily for your own home. However, for businesses and commercial properties, the money made from solar panels, including feed-in tariffs, might be subject to taxes.

Are solar and energy storage installations subject to VAT?

All solar and energy storage installations, including maintenance to existing sites, should be subject to 0% VAT. This should include residential energy storage when installed as a standalone measure.
